1. In view of the above referred orders issued by The Government of Maharashtra and in order to reduce the physical presence of lawyers and litigants due to the prevailing situation of COVID-19 and considering the precautionary measures due to COVID-19, it is hereby notified for the information of the Advocates and the parties appearing in-person that, daily boards of physical hearing (Bench Number 1, 2 & 3) from 03rd May to 7th May 2021 of State Consumer Disputes Redressal Commission, Maharashtra Mumbai bench are hereby discharged. 2. Urgent matter will be taken up on VC at 02:00pm on 04th and 05th May.
3. On Thursday i.e. 6th May 2021, Virtual Hearing of Mumbai Bench matters will be taken up at 11:00 am and Circuit Bench Nashik Bench matters will be taken up at 02:00 pm.
4. On Friday, i.e. 07th May 2021, Virtual Hearing of Pune Circuit Bench matters will be taken up at 11:00 am and Kolhapur Circuit Bench matters will be taken up at 02:00 pm. (Only for Urgent Matters).

During Summer Vacations (i.e. from 10th May 2021 to 4th June 2021) Urgent matters of Mumbai bench will be taken at 11.00 am and Nashik Circuit Bench will be taken at 02:00 pm through VC on Thursday only. Urgent matters of Pune Circuit Bench, will be taken at 11.00 a.m. & Kolhapur Circuit Bench matters will be taken at 2.00 p.m. through VC on Friday only. (Only for Urgent Matters).

8. The Applications/ Praecipes should be precise mentioning the grounds for urgency in brief, the date on which the circulation is sought, last date and scheduled date.

9. Only urgent matters will be taken up by the Commission.

10. The Advocates and Parties-in-person shall not move circulation Praecipes for final hearing.

11. The parties or Advocates who wants to file Written Statements,, Written Versions, Affidavits, or any other applications, may file before registry at Kala Ghoda office. Concerned staff present on that day should accept it and make endorsement on it of received on date with name and signature. Also make it sure to file in concern case file. Though above documents are accepted by the Registry of Commission, Hon'ble Bench will decide whether to take it on record or not on next hearing date.
